## **TICKETING & SEATING OPTIONS:**

Please be reminded that you may not be able to print your tickets from home. If you do not have physical tickets, you will need to download the Ticketmaster mobile app by following these steps:

- Download the Ticketmaster mobile app, available in the Google Play Store or the iTunes App Store
  - Log in using the email address and password associated with your Ticketmaster account
  - Within the app, go to “Events” and select your event to view your tickets
  - If you are an iPhone user, your next step is to tap “add to wallet” and you are done!
  - If you are an Android user, you need to keep your ticket screen open as you approach the venue – or take a screenshot in case of connectivity issues

All Pit Party attendees must have a show ticket AND a Pit Pass for entry into the Pit Party. This includes all children and the parent(s)/guardian(s) wishing to accompany them into the Pit Party.

If you experience any seating issues upon arrival, please contact the nearest usher and they will accommodate to the best of their ability.

## **SMOKING:**

There is no smoking permitted in any of The Dow Event Center facilities; however, we do have an outdoor smoking section that will be located behind section 11 of the concourse for this event.

## **CONCESSIONS:**

Standard concessions will be available for purchase throughout the concourse.

## **SECURITY PROCEDURES:**

- No guns, knives or weapons of any kind including pepper spray, mace and toy/fake weapons

- No alcohol or illegal substances
- No aerosol cans
- No animals except service animals
- No laser pointers
- No drones
- Any other items deemed unsafe by venue personnel
