TICKETS & SEATING:

Please be reminded that you may not be able to print your tickets from home. If you do not have physical tickets, you will need to download the Ticketmaster mobile app by following these steps:

- Download the Ticketmaster mobile app, available in the Google Play Store or the iTunes App Store
- Log in using the email address and password associated with your Ticketmaster account
- Within the app, go to “Events” and select your event to view your tickets
- If you are an iPhone user, your next step is to tap “add to wallet” and you are done!
- If you are an Android user, you need to keep your ticket screen open as you approach the venue – or take a screenshot in case of connectivity issues

For all handicap accessible seating, please contact The Dow Event Center Box Office in advance for availability at 989-759-1330. The Dow Event Center Box Office is open Thursdays, 10:00 a.m. – 2:00 p.m. and Fridays, 10:00 a.m. – 5:00 p.m. If unable to connect with the box office, please leave them a detailed message with your contact information and a box office representative will contact you as soon as possible.

If you experience any seating issues upon arrival, please contact the nearest usher and they will accommodate to the best of their ability due to limited seating flexibility for this show.

Meet & Greet:

Meet & Greet Experience ticket purchasers should go to the Will Call window at the box office on the show day to pick up the Meet & Greet passes and after-show instructions. Each adult and child (age two and up) in a group must have a Meet & Greet Upgrade ticket. The Meet & Greet Experience will start shortly after the end of the show.

Please make sure to bring your camera (no professional cameras – those with detachable lenses), as you will want to capture every moment!

Parents, please note that whilst most children are excited to meet their favorite characters up-close, others can feel frightened. If your child is scared or hesitant to meet Blippi, we recommend moving to



the back of the line. This will allow your child the extra time they may need to warm up to Blippi and see how they interact with other children present.

****Admission to the performance is not included in the Meet & Greet Upgrade ticket. This is a separate upgrade that must be purchased in advance.***

****Children age 12 and under must be accompanied by a parent/guardian. Each child, parent or guardian must have a show ticket as well as a Meet & Greet Upgrade ticket to attend.***

CONCESSIONS:

Standard concessions will be available for purchase. Outside food and beverage is not permitted.

COVID-19 POLICY:

The safety of our guests is our top priority! In accordance with recommendations made by the CDC and local public health authorities, The Dow Event Center has implemented the following policies and procedures to ensure safe and enjoyable events for all guests.

- Masks are welcome at all shows. The CDC & local authorities strongly recommend wearing facemasks while indoors regardless of vaccination status. All guests are encouraged to wear masks while attending events at The Dow Event Center.
- Hand sanitizer will be readily available to all guests and staff, including at every entrance and concessions stand. Please remember to wash your hands thoroughly when visiting the restrooms!
- The Dow Event Center will be conducting increased cleaning of high touch surfaces utilizing electrostatic sprayers.
- The Dow Event Center air exchange rate will be increased from normal settings for shows and the disinfection of air handling units will be conducted regularly.
- Please do not enter the facility if you are awaiting the results of a COVID-19 test or are experiencing any of the following symptoms: fever, chills, shortness of breath, cough, fatigue, body aches, sore throat, runny nose or any other symptoms indicating illness.

SECURITY PROCEDURES:

- Fans are encouraged to arrive early to account for traffic, parking, lines, security and entering the venue.
- All guests are subject to a search of coats and bags and will be required to be wanded or pass through a metal detector.

BAG POLICY:



No bags, briefcases, backpacks or purses larger than 14" x 14" x 6". All bags will be subject to a thorough inspection. Diaper bags will be allowed after thorough inspection if a guest is accompanied by a child.

CAMERA POLICY:

- No professional cameras – those with detachable lenses
- No professional video or audio recording devices
- No selfie sticks
- No electronic equipment including computers, tablets, GoPro devices or tripods

PROHIBITED ITEMS:

Below is a partial list of the items prohibited at The Dow Event Center. For a full list, please visit our FAQ page at DowEventCenter.com. In the interest of our guests' safety, the following items may NOT be brought into The Dow Event Center:

- No guns, knives or weapons of any kind including pepper spray, mace and toy/fake weapons
- No bags, briefcases, backpacks or purses larger than 14" x 14" x 6". All bags will be subject to a thorough inspection. Diaper bags will be allowed after thorough inspection if guest is accompanied by child.
- No outside food or beverage items
- No artificial noisemakers
- No large umbrellas – small compact umbrellas will be allowed after thorough inspection
- No bottles, cans, glass or liquid containers
- No alcohol or illegal substances
- No aerosol cans
- No animals except service animals
- No laser pointers
- No drones
- Any other items deemed unsafe by venue personnel

****Additional items may be added on an event by event basis and dictated by venue personnel.***

****Patrons in possession of prohibited items during a search will be required to return the items to their vehicle or the items will be confiscated or disposed of properly. The Dow Event Center will not safeguard any personal belongings or items of any type.***
