TICKETING & SEATING OPTIONS:

Please be reminded that you may not be able to print your tickets from home. If you do not have physical tickets, you will need to download the Ticketmaster mobile app by following these steps:

- Download the Ticketmaster mobile app, available in the Google Play Store or the iTunes App Store
- Log in using the email address and password associated with your Ticketmaster account
- Within the app, go to “Events” and select your event to view your tickets
- If you are an iPhone user, your next step is to tap “add to wallet” and you are done!
- If you are an Android user, you need to keep your ticket screen open as you approach the venue – or take a screenshot in case of connectivity issues

SMOKING:

There is no smoking permitted inside The Dow Event Center; however, we do have a smoking section that will be located outside of Section 21.

CONCESSIONS:

Standard concessions will be available for purchase. Outside food and beverage is not permitted.

SECURITY PROCEDURES:

- Fans are encouraged to arrive early to account for traffic, parking, lines, security and entering the venue.
- All guests are subject to a search of coats and bags and will be required to be wanded or pass through a metal detector.



BAG POLICY:

No bags, briefcases, backpacks or purses larger than 14" x 14" x 6". All bags will be subject to a thorough inspection. Diaper bags will be allowed after thorough inspection if a guest is accompanied by a child.

CAMERA POLICY:

Although cameras are allowed, the use of any video recording device is prohibited. This includes the use of cell phones that can be used to capture videos.

COVID-19 PROTOCOLS:

The safety of our guests is our top priority! In accordance with recommendations made by the CDC and local public health authorities, The Dow Event Center and Huntington Event Park has implemented the following policies and procedures to ensure safe and enjoyable events for all guests.

- Masks are welcome at all shows. The CDC and local authorities strongly recommend wearing face masks while indoors regardless of vaccination status. All guests are encouraged to wear masks while attending events at The Dow Event Center and Huntington Event Park.
- Hand sanitizer will be readily available to all guests and staff, including at every entrance and concessions stand. Please remember to wash your hands thoroughly when visiting the restrooms!
- The Dow Event Center and Huntington Event Park will be conducting increased cleaning of high touch surfaces utilizing electrostatic sprayers.

- The Dow Event Center air exchange rate will be increased from normal settings for shows and the disinfection of air handling units will be conducted regularly.
 - Please do not enter the facility if you are awaiting the results of a COVID-19 test or are experiencing any of the following symptoms: fever, chills, shortness of breath, cough, fatigue, body aches, sore throat, runny nose or any other symptoms indicating illness.

Additional requirements and safety procedures may be implemented based on the requirements of individual shows. Please visit the individual event pages for any additional requirements.

PROHIBITED ITEMS:

Below is a partial list of the items prohibited at The Dow Event Center. For a full list, please visit our FAQ page at DowEventCenter.com. In the interest of our guests' safety, the following items may NOT be brought into The Dow Event Center:

- No guns, knives or weapons of any kind including pepper spray, mace and toy/fake weapons
- No bags, briefcases, backpacks or purses larger than 14" x 14" x 6". All bags will be subject to a thorough inspection. Diaper bags will be allowed after thorough inspection if guest is accompanied by child.
- Money In The Bank Briefcases are not permitted to be brought into the venue, but may be purchased once inside.

Only WWE brand masks will be permitted (This does not pertain to PPE masks)

- No outside food or beverage items
- No artificial noisemakers
- No large umbrellas – small compact umbrellas will be allowed after thorough inspection

- No bottles, cans, glass or liquid containers
 - No alcohol or illegal substances
 - No aerosol cans
 - No animals except service animals
 - No laser pointers
 - No drones
 - Any other items deemed unsafe by venue personnel

*Additional items may be added on an event by event basis and dictated by venue personnel.

*Patrons in possession of prohibited items during a search will be required to return the items to their vehicle or the items will be confiscated or disposed of properly. The Dow Event Center will not safeguard any personal belongings or items of any type.

IMPORTANT RINGSIDE GUIDELINES:

- No signs can be displayed that contain offensive language or images. In addition, no sign should contain free advertisements such as e-mail addresses, .com advertising, phone numbers or any other public establishments.
- All signs that are deemed inappropriate will be confiscated immediately.
- Fans are not allowed to touch WWE Talent at any time.
- Any throwing of items or spitting on the wrestlers will not be permitted. Any fan caught doing so will be immediately removed from the venue.
- Any fan that enters the barricaded ringside area will be immediately escorted to the venue's security office and prosecuted to the fullest extent of the law.
