## SECURITY PROCEDURES

- Fans are encouraged to arrive early to account for traffic, parking, lines, security and entering the venue.
- All guests are subject to a search and will be required to be wanded or pass through a metal detector.

## CONCESSIONS

Standard concessions will be available for purchase. Outside food and beverage is not permitted. All purchases are cashless only.

## BAG POLICY

12" x 12" x 6" Clear Bags permitted. Small clutches no larger than 4.5" x 6.5" x 2" OR clear, one-gallon bags for medical or parenting needs will be permitted.

No bags, backpacks or purses, other than those required for medical or parenting needs, will be permitted into the venue.

Bags in the medical/essential category will be screened by security personnel. Guests with parenting/medical bags must enter through the main entrance of the building to undergo additional security screening.

## CAMERA POLICY:

Professional cameras and video recording and streaming is strictly prohibited

# COVID-19 PROTOCOLS:

The safety of our guests is our top priority! In accordance with recommendations made by the CDC and local public health authorities, The Dow Event Center and Jolt Credit Union Event Park has implemented the following policies and procedures to ensure safe and enjoyable events for all guests.

- Masks are welcome at all shows. The CDC and local authorities strongly recommend wearing face masks while indoors regardless of vaccination status. All guests are encouraged to wear masks while attending events at The Dow Event Center and Jolt Credit Union Event Park.
- Hand sanitizer will be readily available to all guests and staff, including at every entrance and concessions stand. Please remember to wash your hands thoroughly when visiting the restrooms!
- The Dow Event Center and Jolt Credit Union Event Park will be conducting increased cleaning of high touch surfaces utilizing electrostatic sprayers.
- The Dow Event Center air exchange rate will be increased from normal settings for shows and the disinfection of air handling units will be conducted regularly.
- Please do not enter the facility if you are awaiting the results of a COVID-19 test or are experiencing any of the following symptoms: fever, chills, shortness of breath, cough, fatigue, body aches, sore throat, runny nose or any other symptoms indicating illness.

## PROHIBITED ITEMS:

Below is a partial list of the items prohibited at The Dow Event Center. For a full list, please visit our FAQ page at [DowEventCenter.com](http://DowEventCenter.com). In the interest of our guests' safety, the following items may NOT be brought into The Dow Event Center:

- No guns, knives or weapons of any kind including pepper spray, mace and toy/fake weapons
  - No bags, briefcases, backpacks or purses larger than 14" x 14" x 6". All bags will be subject to a thorough inspection. Diaper bags will be allowed after thorough inspection if a guest is accompanied by a child.
  - No outside food or beverage items
  - No artificial noisemakers
  - No large umbrellas – small compact umbrellas will be allowed after thorough inspection
  - No bottles, cans, glass or liquid containers
  - No alcohol or illegal substances
  - No aerosol cans
  - No animals except service animals
  - No laser pointers
  - No drones
  - Any other items deemed unsafe by venue personnel
- \*Additional items may be added on an event by event basis and dictated by venue personnel.  
\*Patrons in possession of prohibited items during a search will be required to return the items to their vehicle or the items will be confiscated or disposed of properly. The Dow Event Center will not safeguard any personal belongings or items of any type.  
\*Only WWE brand masks and all PPE masks will be permitted  
\*Outside Money in the Bank briefcases are not permitted, but may be purchased inside.
